# CORE Overview

First come – First served

Offset higher zero emission cost

CARB determines funding amounts

Stacking allowed and no scrappage required

Enhancements for infrastructure, small business, and DAC

# CORE Approved Funding Plan

- CARB approved \$273 million for zero emission off-road
  - \$77 million to fund the 2022 contingency list
- Remaining funding to this funding year.
- CHC, CHE, and rail
  - Increase funding to \$1 million per equipment

# CORE Heavy-Duty Off-Road Categories

- Terminal tractors
- Transport refrigeration units (TRU)
- Large forklifts
- Cargo handling equipment
- Specific airport GSE (cargo loaders, wide-body tugs)
- Railcar movers and freight locomotives
- Mobile and aircraft ground power units
- Mobile shore power cable mgt. systems and CHC shore-side supply equipment
- Construction equipment
- Agricultural equipment
- Commercial harbor craft

# CORE Heavy-Duty Updates

- All equipment must be 19kW or greater
- Removed business days, changed to calendar days
- MPU/GPU must be 40kWh or greater
- Total funding not 20%, per category,
- Added inductive charging
- Government and public agencies must submit a PO within 365 calendar days
- \$10 million set aside for small business, first 180 days.

# CORE CHC Updates

- \$1 million per vessel
- Use letter of intent in lieu of purchase order (PO)
- CHC must provide a PO within 730 calendar days
  - Provide the hull identification number, unique ID.
  - Expected delivery date
- No renewal beyond 32 months (945 calendar days)
